The Cal Fire Rep tells you it is a Sikorsky S-64 "Skycrane" and it can hold 1000 gallons of water. Create a brief message to the EOC let them know that Air Operation at the reservoir are in progress.
10:25 Send this message over the next 15 minutes	You are starting to see a steady stream of private cars heading north. All the cars are packed with their possessions. One resident stopped and told you it was very smoky up on the ridge. Create a brief message to the EOC passing on this observation.
10:50 Send this message over the next 15 minutes	You hear the Sheriff on the radio asking for more road barricades. You ask if you can help get the message to the EOC. He says yes, you hand him a message form, and scribbles out the message below. Cool a third-party message! Send the message to the EOC.
11:15 Send this message over the next 15 minutes	You see 5, 6, no make that 7 engines heading up Montebello Road. The Cal Fire Rep tells you that they are going to reinforce the eastern perimeter of the fire. Evacuations are required for the residents up there. Create a brief message passing on this information to the EOC.
11:30	The evacuation zone has been expanded and you are asked to leave. Create a brief message to the ICP of the situation and then return to the ICP. End of Exercise.
