Every person who, while taking and subscribing to the oath or affirmation required by this chapter states as true any material matter which he knows to be false, is guilty of perjury, and is punishable by imprisonment in the state prison not less than one nor more than 14 years. Every person having taken and subscribed to the oath or affirmation required by this chapter, who, while in the employ of, or service with, that state or any county, city, city and county, state agency, public district, or disaster council or emergency organization advocates or becomes a member of any party or organization, political or otherwise, that advocates the overthrow of government of the United States by force or violence or other unlawful means, is guilty of a felony and is punishable by imprisonment in the state prison.

## Code of Conduct for Cupertino OES Volunteers

As a member of the Cupertino Citizen Corps, I will:

- Include everyone as I realize that all individuals have a role in emergency preparedness.
- Consider all ideas and suggestions by others.
- Use the Incident Command System and adhere to the chain of command.
- Report complaints/violations to your section chief or OES staff.
- Speak within my authority and not make promises on behalf of the OES unless I have been given prior approval to make such promises.
- Always adhere to approved training information.
- Attempt to keep my promises.
- Attempt to solve problems at the lowest possible level.
- Maintain a positive attitude about Emergency Preparedness and avoid any negative comments about people from Cupertino or other emergency organizations.
- Represent Citizen Corps and OES with professionalism.
- Coordinate and cooperate with other volunteers, sheriff's deputies, fire department personnel or other jurisdictional authority.
- Not use my status in the organization for personal gain.
- Not violate or disregard published safety rules or common safety practices.
- Not possess alcoholic beverages, illegal/unauthorized drugs, or being under the influence of intoxicating beverages/drugs while on duty.
- Not be in the possession of unauthorized weapons while on duty.
- Not fight with citizens, other volunteers, sheriff's deputies, fire department personnel or other jurisdictional authority while on duty.
- Not be in possession of city property or others personal property unless so authorized.
- Not willfully abuse, damage deface, misuse City equipment or property.

*Failure to adhere to this code of conduct may result in suspension of duties or removal from the Citizen Corps roster, based on the decision of the Emergency Services Coordinator.*
